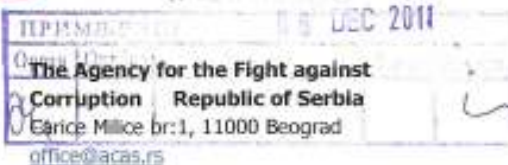
1. Otklanjanje uverenja građana Srbije ali i Evropske Unije da Srbija institucionalno simulira borbu protiv korupcije,

**Re: Public Note apropos the 9th
December, the UN International
Anti-Corruption Day – Suggestion
for the Abolishment of the Agency
for the Fight against Corruption**

Bearing in mind meagre results achieved by the Agency for the Fight against Corruption up to now, we appeal on your moral dignity and your awareness of the extent and pernicious consequences of systematic corruption in Serbia to initiate abolishment of the Agency. Such a move would help in achieving three main objectives:

1. Dispersing conviction of citizens of both Serbia and EU that Serbia simulates the fight against corruption in an institutionalized manner;
2. Removal of barriers and excuses for introducing a real institutionalized fight against corruption;
3. Cardinal budgetary savings of the Serbian taxpayers' money and EU funds.

ARGUMENTATION

Leaving aside lack of Agency's results in other sectors, we will mention only **two health-related affairs** which the executive director of the US National Whistleblowers Center in Washington, Mr. Stephen M. Kohn, referred to as **mass murder**

1.Belgrade's Emergency Service affair. Due to illegal commercial liaisons of emergency doctors with funeral undertakers, 53 patients passed away under unclear circumstances. The Agency for the Fight against Corruption selectively blamed only alleged perpetrators for

2. **Ugrožavanje prava na život pacijenata obolelih od malignih bolesti radi sticanja protivpravne materijalne dobiti**- trgovina listama čekanja u Institutu za onkologiju Vojvodine. Na štetu građana Srbije potpisan ugovor sa stranim osiguravajućim društvom o rentiranju ionako nedovoljnih kapaciteta za lečenje po pravilu da oni koji plaćaju imaju prednost nad domaćim pacijentima. Uz navedeno domaćim pacijentima je svesnim nepoštovanjem zakona onemogućeno lečenje u drugim centrima. Ugrožavanje prava na život obolelih od malignih bolesti institucionalno je utvrdio Ombudsman Republike Srbije

the criminal offence but intentionally refused to persecute officials in responsible institutions for smothering up the criminal offence since 2006, obstructing and blocking the investigation, and clashing with a whistleblower

2.Imperilment of the right to live of cancer patients in order to obtain illegal material benefit - trading with waiting lists in the Institute of Oncology of Vojvodina. Contrary to the interests of Serbian citizens, a contract with a foreign health insurance company was signed to rent already insufficient treatment capacities in such a way that those who pay have an advantage over domestic patients. Moreover, intentional ignorance of law disabled local patients to be treated in other medical centres. Endangerment of the right to live of cancer patients has been institutionally verified by the Ombudsman of the Republic of Serbia (<http://www.ombudsman.rs/index.php/lang-sr/misljenja-preporuke-i-stavovi/1159-2010-11-12-13-21-07>), and publicly recognized by the Serbian Minister of Health (<http://www.021.rs/Novi-Sad/Vesti/Zid-cutanja-na-Institutu-za-onkologiju.html>). Information on this disturbing situation we personally submitted to the Director of the Agency, Ms. Zorana Marković (<http://www.pistaljka.rs/home/read/101>), but to no avail"
